

Recognising the issues relating to personal safety of campaigners being on their own, the Government has advised that more than one campaigner may be on a street at any given time. However, 'gathering' is not permitted.

# Plan for GOTV

Activity must be considered in accordance with the prevailing guidance on gathering, hygiene and social distancing.

## CAMPAIGN CENTRES & COMMITTEE ROOMS:

Nominations

## The nomination process has been temporarily changed to limit the need for inperson contact.

Additional guidance and legislation will reduce the number of signatures required to validate a candidate's nomination.

- For elections in 2021, only 2 signatures are required for local council nomination papers which will limit the need for inperson contact.
- Please see further guidance for the requirements for Police and Crime Commissioner and Combined Authority Mayoral elections.
- It is still necessary to obtain physical signatures on a nomination paper.
- We would strongly suggest that you try to line up voters to sign nomination papers by telephone or email, in advance of visiting to obtain the

signature. This will reduce the number of doors you need to knock on and will also allow you to plan, with the elector, how the signature can be collected in a Covid-safe manner.

- Please ensure that at all times you follow current Government guidance on social distancing and where pieces of paper are being handed over (or picked up from a doorstep) we encourage you to wear a face covering and use hand sanitiser.
- Please contact the Electoral Services department at your local authority to ask for information on how they intend to conduct the checking/ submission process. It may be that initial checks can be carried out via email (using a scan or image of the signed paper) or you may need to book an appointment to do this in person.
- As ever, the sooner you can complete and submit your nomination papers the better. If papers are not submitted until the last minute there is less time to correct errors and an increased risk that we will not be able to validly nominate a candidate in a given seat.
- Letters of authorisation for those nominating candidates on behalf of the Party can be obtained from your Area Campaign Manager.
