

### Our changing age structure






### What is an Age-friendly Community?


An Age-friendly Community is a place that enables people to age well and live a good later life.


Somewhere that people can stay living in their homes, participate in the activities that they value, and contribute to their communities, for as long as possible.


WHO's Age-friendly Communities framework acts as a guide for communities to achieve this goal.



### WHO Age-friendly Communities Framework







### Benefits of the Age-friendly Communities approach







# Why is Age Friendly Leeds Important?

- An ageing population:
  - 1/3 of people in Leeds are 50+. We are a young city but many people in later life call Leeds their home!
- The 60+ population group is growing:
  - By 2033 we will have an estimated 19,300 more people aged 60+ in Leeds significant growth in 80+
- Our older population is becoming increasingly diverse:
  - 1/10 people aged 50+are from ethnically diverse communities (13%), increasing to 2/10 for people aged 30-49
  - 19% of people aged 50+ live in the 10% most deprived areas nationally. This increases to around 24% in people across all ages
- The number of years that people spend in good health in later life is unequal between different communities.
  - People living in more deprived communities on average spend more years in poorer health and this starts in their early 50s



# Working in Partnership with Providers

- Referrals for routine visits e.g. med prompt, catheter care
- Working towards clinical delegation with dedicated nurse
- Providing consistency and capacity
- Co-ordinated care individual, family, ASC, primary health
- Small neighbourhood teams
- Paid for whole shift through an enhanced hourly rate
- Flexibility & freedom to personalise support
- Shared training and developing a senior care worker role
- Ageing Well and prevention principles embedded in service specification
- Jointly responsible for all pickups in area
- New role in care planning, reviews and adjustments
- Delivery focused on outcomes and independence
- Creating and supporting community & social connections



# Experiences of ethnically diverse communities: Carers and third sector support

- Work with Hamara, ABA Leeds and Touchstone on reaching out to carers from ethnically diverse communities.
- Action group, which is a spin off from the Leeds Carers Partnership Board.
- · Community based roadshows.
- Working on a joint Lottery bid amongst other things.







