### **Recent Disorder & Response**

## **Recent Disorder & Response (2)**

| Sunday 4 August     | Prayer Walk – 2-300 participants   |

| Wednesday 14 August | Extraordinary Council Meeting – unanimous cross-party support for Cohesion Motion  |
| Wednesday 21 August | Visit by Lord Khan – meetings at Sunderland Minster and St Mark's Road Mosque  |
| Thursday 22 August  | Safer Sunderland Partnership meeting – focus on response to the disorder and Police and other partner actions  |

### **City sentiment & reflections**

- City described as a 'ticking time bomb' building on prior Justice for Chelsea and EDL events (over past decade), Brexit was a key point in time and feelings within some white, settled communities of having less hope and opportunity, have grown since then.
- Our diverse communities feel as white communities do on concerns about asylum and immigration issues and impacts. It's deeply unfair and unacceptable that Muslim communities in particular have been targeted and attacked by the far right.
- Muslim communities are fearful for their safety and don't feel that what has happened is being acknowledged as Islamophobia at a national level. (Council motion on 14 August 2024, agreed to write to Home Office urging them to appoint an independent Government advisor on Islamophobia as soon as possible).
- Social media is a fundamental problem both the encrypted, disorder-convening side, and the side out in the open spreading misinformation.



## City sentiment & reflections (2)

- The Police are under-resourced in the event of dealing with the type of disorder recently seen.
   Additional resource is also needed to do vital engagement and reassurance work in communities.
- The publicity around zero tolerance, swift arrests, fitting charges and sentences undoubtedly had a dissuading effect in terms of the further suggested attacks on targeted locations around the country on 7 August, including some organisations and premises in Sunderland.
- Residents from <u>all</u> of our communities need the space and agency to voice their concerns and it will take skill and new approaches to facilitate these conversations and then shape solutions within a comprehensive, co-created cohesion strategy.



#### **Our Asks of Government**

- Continuation of the additional Home Office security funding and measures for Mosques
- An urgent review of the national curriculum, and cohesion and anti-racism educational resources for schools, colleges and universities, needs to be undertaken.
- Funding cuts over the past fourteen years have had a real impact in particular, the decimation of budgets for youth provision and for cohesion work has contributed to this situation and we appeal to the new Government to restore this funding.



#### **Our Asks of Government (2)**

- Review of the Further Education model and the move away from community-based provision
- Adequate and sustained funding to make interventions count and deliver long-term change including for:
  - targeted youth interventions
  - drug and alcohol use interventions
  - violence reduction
  - anti-social behaviour
  - temporary accommodation, and
  - supported housing
- Invitations extended to Ministers to visit our community projects and models of good practice, for example the SARA, HALO and SAIL projects.



### **Next steps**

- Development of action plan for use of MHCLG Recovery Fund Grant spend required by 31 March 2025
- Staying in close contact with our existing networks of organisations and faith/community leaders
- Production of a comprehensive Cohesion Strategy for the city
- Core principles for our working going forward
  - Partnership approach
  - Co-created
  - Embedded as appropriate in all partners' work
  - Evidence-led based on comprehensive engagement with <u>all</u> of our communities
